ARTICLE I Constable

[Adopted 11-7-1989 by Ord. No.89-1 as § 2.01 of the 1989 Code]

§ 32-1. When effective. [Added 11-4-2003]

This article shall apply if and when the position of Town Constable is reestablished by the Town Meeting as described in § 60.10(1)(b)(4), Wis. Stats., and until that occurs the position of Town Constable is abolished and this article shall have no effect.

§ 32-2. Statutory authority.

Pursuant to §§ 60.22(4) and 60.35, Wis. Stats., the Town Board of Supervisors of the Town of Pleasant Springs. Dane County. hereby establishes the jurisdiction and duties of the Town Constable of the Town of Pleasant Springs, Dane County. as described herein.

§ 32-3. Jurisdiction and duties.

A. The Town Constable of the Town of Pleasant Springs, Dane County, shall keep and preserve the peace within the Town of Pleasant Springs and shall have the full peace powers to arrest and apprehend any person for felony or breach of peace pursuant to § 59.28, Wis. Stats., and for purposes of carrying out such duties shall be considered a peace officer as defined in § 939.22(22), Wis. Stats., and shall have and exercise such

further powers as are available under Wisconsin law in the course of enforcing the Town of Pleasant Springs Municipal Code and ordinances.

B. The Town Constable of the Town of Pleasant Springs. Dane County. shall also have all the powers of an officer contemplated by Ch. 800, Wis. Stats., specifically including, but not limited to. the power to arrest without a warrant for the violation of a municipal ordinance if such constable has reasonable grounds to believe that the person to be arrested is violating or has violated such ordinance.

§ 32-4. Provisions not exclusive.

- A. Other ordinance. Adoption of this article does not preclude the Town Board from adopting any other ordinance or providing for the enforcement of any other law or ordinance relating to the same or other matter.
- B. Other remedies. The jurisdiction and duties of the Town Constable as stated herein shall not preclude the Town Board or any other Town officer from proceeding under any ordinance or law or by any other enforcement method to enforce any ordinance. regulation or order, as permitted under Wisconsin law.

ARTICLE II Treasurer

§ 32-5. Exemption from bond.

The Treasurer of the Town of Pleasant Springs is exempted from giving the bond specified in § 70.67(I). Wis. Stats. The Town hereby obligates itself to pay (in case its Treasurer fails so to do) all state and county taxes which the Treasurer is required to pay to the County Treasurer.

ARTICLE III

Assessor

§ 32-6. Confidential information.

Whenever the Assessor. in the performance of the Assessor's duties. requests or obtains income and expense information pursuant to § 70.47(7) (af), Wis. Stats., or any successor statute thereto, then such income and expense information that is provided to the Assessor shall be held by the Assessor on a confidential basis, except. however, that said information may be revealed to and used by persons in the discharge of duties imposed by law. in the discharge of duties imposed by office (including but not limited to use by the Assessor in performance of official duties of the Assessor's office and use by the Board of Review in performance of its official duties). or pursuant to order of a court. Information shall not be redisclosed by any such individuals to any person or persons not authorized to receive that information.

Income and expense information provided to the Assessor under § 70.47(7) (af), Wis. Stats., unless a court determines that it is inaccurate, is, per§ 70.47(7) (a0, Wis. Stats., not subject to the right of inspection and copying under§ 19.35(1), Wis. Stats.
